# GIT1 shRNA (r) Lentiviral Particles: sc-45954-V



#### BACKGROUND

Heterotrimeric G protein-mediated signal transduction is a dynamically regulated process with the intensity of signal decreasing over time despite the continued presence of the agonist. G protein-coupled receptor kinases (GRKs) are activated by activated G protein-coupled receptors, and they function to phosphorylate and inactivate cell surface receptors in the heterotrimeric G protein signaling cascade. GIT1 (for GRK-interactor 1) and GIT2 are GTPase-activating proteins (GAP) for members of the ADP ribosylation factor (ARF) family of small GTP-binding proteins, which are involved in vesicular traffick-ing. GIT1 overexpression results in reduced internalization and resensitization of  $\beta$ 2-adrenergic receptor, thus reducing  $\beta$ 2-adrenergic receptor signaling.

#### CHROMOSOMAL LOCATION

Genetic locus: Git1 (rat) mapping to 10q26.

#### PRODUCT

GIT1 shRNA (r) Lentiviral Particles is a pool of concentrated, transductionready viral particles containing 3 target-specific constructs that encode 19-25 nt (plus hairpin) shRNA designed to knock down gene expression. Each vial contains 200  $\mu$ l frozen stock containing 1.0 x 10<sup>6</sup> infectious units of virus (IFU) in Dulbecco's Modified Eagle's Medium with 25 mM HEPES pH 7.3. Suitable for 10-20 transductions. Also see GIT1 siRNA (r): sc-45954 and GIT1 shRNA Plasmid (r): sc-45954-SH as alternate gene silencing products.

#### STORAGE

Store lentiviral particles at -80° C. Stable for at least one year from the date of shipment. Once thawed, particles can be stored at 4° C for up to one week. Avoid repeated freeze thaw cycles.

#### APPLICATIONS

GIT1 shRNA (r) Lentiviral Particles is recommended for the inhibition of GIT1 expression in rat cells.

#### SUPPORT REAGENTS

Control shRNA Lentiviral Particles: sc-108080. Available as 200  $\mu$ l frozen viral stock containing 1.0 x 10<sup>6</sup> infectious units of virus (IFU); contains an shRNA construct encoding a scrambled sequence that will not lead to the specific degradation of any known cellular mRNA.

#### GENE EXPRESSION MONITORING

GIT1 (A-1): sc-365084 is recommended as a control antibody for monitoring of GIT1 gene expression knockdown by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000) or immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500).

To ensure optimal results, the following support (secondary) reagents are recommended: 1) Western Blotting: use goat anti-mouse IgG-HRP: sc-2005 (dilution range: 1:2000-1:32,000) or Cruz Marker™ compatible goat anti-mouse IgG-HRP: sc-2031 (dilution range: 1:2000-1:5000), Cruz Marker™ Molecular Weight Standards: sc-2035, TBS Blotto A Blocking Reagent: sc-2333 and Western Blotting Luminol Reagent: sc-2048. 2) Immunofluo-rescence: use goat anti-mouse IgG-TR: sc-2781 (dilution range: 1:100-1:400) with UltraCruz™ Mounting Medium: sc-24941.

#### **RT-PCR REAGENTS**

Semi-quantitative RT-PCR may be performed to monitor GIT1 gene expression knockdown using RT-PCR Primer: GIT1 (r)-PR: sc-45954-PR (20  $\mu$ l, 545 bp). Annealing temperature for the primers should be 55-60° C and the extension temperature should be 68-72° C.

#### BIOSAFETY

Lentiviral particles can be employed in standard Biosafety Level 2 tissue culture facilities (and should be treated with the same level of caution as with any other potentially infectious reagent). Lentiviral particles are replication-incompetent and are designed to self-inactivate after transduction and integration of shRNA constructs into genomic DNA of target cells.
