Specificity: In Western blotting, this antibody recognizes proteins in a MW range of 265-400kDa, identified

as different glycoforms of MUC1. This antibody reacts with the DTRP epitope within the tandem repeats. In immunohistochemical assays, it superbly stains routine formalin/paraffin carcinoma tissues. An antibody to MUC1 is useful as a pan-epithelial marker for detecting early metastatic

loci of carcinoma in bone marrow or liver.

Background: MUC1 is proteolytically cleaved into alpha and beta subunits that form a heterodimeric complex

consisting of the N-terminal alpha subunit and the C-terminal beta subunit. The alpha subunit of MUC1 has cell adhesive properties. It can act both as an adhesion and an anti-adhesion protein. MUC1 may provide a protective layer on epithelial cells against bacterial and enzymatic

attack. The beta subunit contains a C-terminal domain, which is involved in cell signaling

through phosphorylation and protein-protein interactions.

Species Reactivity: Human. Reacts moderately with Pig and Dog. Others not known.

Positive Control: Breast or colon carcinoma.

Cellular Localization: Cytoplasmic and cell surface

Titer/ Working Dilution: Immunohistochemistry (Frozen and Formalin-fixed): 0.5-1 µg/ml

Flow Cytometry: 0.5-1 µg/million cells



Formalin-fixed, paraffin-embedded colon carcinoma stained with MUC1; Clone GP1.4 & E29.

Procedure:

- 1. **Tissue Section Pretreatment (Highly Recommended):** Staining of formalin fixed, paraffin embedded tissue sections is significantly enhanced by pretreatment with Citrate Plus (ScyTek catalog# CPL500).
- Primary Antibody Incubation Time: We suggest an incubation period of 30 minutes at room temperature for human. We suggest an incubation period of 60 minutes at room temperature for Pig and Dog. However, depending upon the fixation conditions and the staining system employed, optimal incubation should be determined by the user.
- 3. **Visualization:** For maximum staining intensity we recommend the "UltraTek HRP Anti-Polyvalent Lab Pack" (ScyTek catalog# UHP125, see IFU for instructions) combined with the "DAB Chromogen/Substrate Bulk Pack (High Contrast)" (ScyTek catalog# ACV500, see IFU for instructions).

Precautions:

Contains Sodium Azide as a preservative (0.09% w/v).

Do not pipette by mouth.

Avoid contact of reagents and specimens with skin and mucous membranes.

Avoid microbial contamination of reagents or increased nonspecific staining may occur.
