Specificity: This monoclonal antibody recognizes a protein of 170kDa, identified as EGFR.

Background: EGFR is type I receptor tyrosine kinase with sequence homology to erbB-1, -2, -3 -4 or HER-1,

-2, -3 -4. It binds to Epidermal Growth Factor (EGF), Transforming Growth Factor-a (TGF-a),

Heparin-binding EGF (HB-EGF), amphiregulin, betacellulin and epiregulin. EGFR is

overexpressed in tumors of breast, brain, bladder, lung, gastric, head, neck, esophagus, cervix, vulva, ovary, and endometrium. It is predominantly present in squamous cell carcinomas.

Species Reactivity: Reacts with human. Others not known.

Positive Control: A431 cells. Placenta, breast, colon, or bladder cancer.

Cellular Localization: Cell surface.

Titer/ Working Dilution: Immunohistochemistry (Formalin-Fixed): 1-2 μg/ml

Flow Cytometry: 0.5-1 µg/million cells

Immunofluorescence: 1-2 μg/ml

Microbiological State: This product is not sterile.

Storage: 2° C 8° C



#### Procedure:

- 1. **Tissue Section Pretreatment (Required):** Staining of formalin fixed, paraffin embedded tissue sections is significantly enhanced by pretreatment with Citrate Plus (ScyTek catalog# CPL500).
- Primary Antibody Incubation Time: We suggest an incubation period of 30 minutes at room temperature.
   However, depending upon the fixation conditions and the staining system employed, optimal incubation should be determined by the user.
- 3. **Visualization:** For maximum staining intensity we recommend the "CRF Anti-Polyvalent HRP Polymer (DAB) Lab Pack" (ScyTek catalog# CPP125, see IFU for instructions), combined with the "DAB Chromogen/Substrate Bulk Pack (High Contrast)" (ScyTek catalog# ACV500, see IFU for instructions).

### Precautions:

Contains Sodium Azide as a preservative (0.09% w/v).

Do not pipette by mouth.

Avoid contact of reagents and specimens with skin and mucous membranes.

Avoid microbial contamination of reagents or increased nonspecific staining may occur.
