### SECTION4 FIRST-AID MEASURES

#### 4.1 General advice

For large fires, apply water from as far as possible. Use large quantities of water applied as a mist or spray. Solid streams of water may be ineffective. Cool affected containers with flooding quantities of water.

## **SECTION6 ACCIDENTAL RELEASE MEASURES**

### **6.1 Person-related safety precautions**

Use personal protective equipment. Avoid breathing vapors, mist or gas. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Beware of vapors accumulating to form explosive concentrations. Vapors can accumulate in low areas.

### **6.2 Measures for environmental protection**

Prevent further leakage or spillage if safe to do so. Do not let enter drains. Discharge into the environment must be avoided.

### **6.3 Measures for containment and cleaning**

Contain spillage, and then collect with non-combustible absorbent material (eg. sand, diatomaceous earth, vermiculite). Place in a container for disposal according to local regulations.
