Section 4 – Hazards Identification

Eye:	Causes eye irritation.

- Inhalation:** Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.

Section 6 – Stability and Reactivity

- Chemical Stability:** Stable under normal temperatures and pressures.
- Materials to avoid:** Strong oxidizing agents.
- Conditions to Avoid:** Incompatible materials.
