A metabolite of Bufuralol, a β -Adrenergic blocker with peripheral vasodilating activity. The toxicological properties of this compound have not been throughly investigated. Exercise due care. May cause irritation

Section 8 - Precautions for Safe Handling and Use

Steps to be Taken in Case Material is Released or Spilled:

Wear respirator, chemical safty goggles, rubber boots and heavy rubber gloves. Sweep up, place in bag and hold for waste disposal. Avoid raising dust. Ventilate area and wash spill site after material pickup is complete.

Waste Disposal Method:

This combustible material may be burned in a chemical incinerator equipped with an afterburner and scrubber. Observe all federal, state and local environmental regulations.

Keep container closed, light sensitive, keek away from heat and open flame, store under nitrogen, refrigerate.
