4. FIRST AID MEASURES

General advice

6. ACCIDENTAL RELEASE MEASURES

Personal precautions

Environmental precautions

Prevent further leakage or spillage if safe to do so. Do not let product enter drains.

Methods and materials for containment and cleaning up

Sweep up and shovel. Contain spillage, and then collect with an electrically protected vacuum cleaner or by wet-brushing and place in container for disposal according to local regulations (see section 13). Do not flush with water. Keep in suitable, closed containers for disposal.

7. HANDLING AND STORAGE

Precautions for safe handling

Avoid formation of dust and aerosols. Provide appropriate exhaust ventilation at places where dust is formed. Keep away from sources of ignition - No smoking. Take measures to prevent the build up of electrostatic charge.

Conditions for safe storage

Keep container tightly closed in a dry and well-ventilated place. Never allow product to get in contact with water during storage. Over time, pressure may increase causing containers to burst. Handle and open container with care. Air sensitive. Moisture sensitive. Hydrolyses readily. Handle and store under inert gas. Store at room temperature.
