



## **CHRONIC HEALTH EFFECTS**

Long term exposure to high dust concentrations may cause changes in lung function i.e. pneumoconiosis; caused by particles less than 0.5 micron penetrating and remaining in the lung.

GENERAL FIRE HAZARDS/HAZARDOUS COMBUSTIBLE PRODUCTS

 $\cdot$  Combustible solid which burns but propagates flame with difficulty.

• Avoid generating dust, particularly clouds of dust in a confined or unventilated space as dusts may form an explosive mixture with air, and any source of ignition, i.e. flame or spark, will cause fire or explosion. Dust clouds generated by the fine grinding of the solid are a particular hazard; accumulations of fine dust may burn rapidly and fiercely if ignited.

Combustion products include: carbon monoxide (CO), carbon dioxide (CO2), other pyrolysis products typical of burning organic material. NOTE: Burns with intense heat. Produces melting, flowing, burning liquid and dense acrid black smoke.

RESPIRATOR Particulate Consult your EHS staff for recommendations EYE · Safety glasses with side shields · Chemical goggles. HANDS/FEET Suitability and durability of glove type is dependent on usage. Important factors in the selection of gloves include: such as:

· frequency and duration of contact,

· chemical resistance of glove material,

· glove thickness and

 $\cdot$  dexterity

Select gloves tested to a relevant standard (e.g. Europe EN 374, US F739).

• When prolonged or frequently repeated contact may occur, a glove with a protection class of 5 or higher (breakthrough time greater than 240 minutes according to EN 374) is recommended.

• When only brief contact is expected, a glove with a protection class of 3 or higher (breakthrough time greater than 60 minutes according to EN 374) is recommended.

· Contaminated gloves should be replaced.

Gloves must only be worn on clean hands. After using gloves, hands should be washed and dried thoroughly. Application of a non-perfumed moisturiser is recommended.

Experience indicates that the following polymers are suitable as glove materials for protection against undissolved, dry solids, where abrasive particles are not present.

· polychloroprene

- · nitrile rubber
- $\cdot$  butyl rubber
- $\cdot$  fluorocaoutchouc

 $\cdot$  polyvinyl chloride

Gloves should be examined for wear and/ or degradation constantly.

■ No special equipment needed when handling small quantities.

#### **ENGINEERING CONTROLS**

· Local exhaust ventilation is required where solids are handled as powders or crystals; even when particulates are relatively large, a certain proportion will be powdered by mutual friction.

· Exhaust ventilation should be designed to prevent accumulation and recirculation of particulates in the workplace.
